FAIR provides objective, comprehensive and impartial processing of our financial aid application.

General Information:

There is a non-refundable application fee, payable by credit card (MasterCard, and Visa).

You do not have to complete the entire application at one time. There are several financial documents you should gather before starting your application. Please note that you can apply even if you have not completed your most recent tax return. You can estimate your income in the Income section of the application and FAIR will update your income once you forward us a copy of your tax return.

Upon completion of the FAIR application, you will need to submit copies of your tax documentation to FAIR for verification. You will be able to upload documents to FAIR once your application is completed by logging back into your application and clicking on the Upload Documents link on the right side of the page below the School Year.

To change your password, click on the Change your Profile link on the left side of the page. If you forget your password, click on the Forgot your Password link on the log in page.

Scholarships are available to families of all income levels. The only requirement to receive tax credit funding is that your child is enrolled in an Arizona Private K-12 school.

Funding for scholarships comes from the tax credit donations of individuals and corporations. Your participation in having your social contacts donate is a great way to increase the funds available for your family's scholarship awards.

Create a profile to apply for the 2021-2022 school year. Once you create your profile, you can start your application, save and finish later, or save and submit. You will also have the ability to attach required documentation and apply for siblings.

As a school we ask that all families apply for scholarship assistance, even if you think you may not qualify.
